### ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **2022 Water Distribution Improvements** will be received at the office of the **Mount Pleasant Town Hall, 8590 Park Drive, Mount Pleasant, NC 28124** until <u>2:00 pm</u> <u>local time on September, 25<sup>th</sup>, 2024</u> at which time the Bids received will be publicly opened and read aloud.

#### Note:

Mt Pleasant is receiving bids for two projects at the same time: this 2022 Water Distribution Improvements project and the Lower Adams Creek Gravity Sewer Outfall project. The water project bids will be opened first. After all bids for the water project have been read and the apparent low bidder announced, contractors that submitted a bid for the sewer project will be given the opportunity to withdraw their bid prior to opening the sewer project bids.

This project consists of the following:

- 1. Approximately 7,340 feet of 12-inch waterline along Main Street and North Drive.
- 2. Approximately 3,630 feet of 12-inch waterline along East Franklin Street.
- 3. Approximately 6,000 feet of 12-inch waterline along NC-49.
- 4. Approximately 4,810 feet of 12-inch waterline along Skyland Drive and West Franklin Street.
- 5. Approximately 610 feet of 2-inch waterline along Empire Drive.
- 6. Approximately 1,100 of 12-inch waterline along Cook Street.
- 7. Approximately 200 feet of 6-inch waterline along Crestwood Drive.

Bidders should closely examine the Sequence of Construction provided in the specifications.
